
## Our Company's Progress Report 2024-25

In the last FY 2024–25, there was a Net Profit of 14 Cr on the Revenue of Rs 266 Cr. The drop in Net Profit was due to sharp rise in Palm Sterin & edible oil prices and previously introduced duty hikes in September 2024—which had pushed the basic rate to 20% and total effective duty to ~27.5%

Further due to the Policy Paralysis by OMC's and Petroleum Ministry there were no tenders floated by OMC's from September 2024 to March 2025, as a result of that there was a significant drop in the Revenues as well as Profits in the Second Half of the FY 2024–25.

Still, we managed to stay afloat and not only made profits but also completed the CBG, Pellets and Glycerine projects to diversify the business risk in the times to come.

We are sure to bounce back in this FY 2025-26 and pursue our journey as planned.

#### **CBG Plant Capacity Utilization**

We are pleased to share that our Compressed Biogas (CBG) plant is now operational. Presently, we are supplying 2 TPD (tons per day) of CBG, and the production is set to scale progressively — reaching 5 TPD by 15th August, 10 TPD by 15th September, and achieving full capacity of 15 TPD by 15th October 2025. In parallel, our biomass pellet production is currently running at 30 TPD and is on track to reach 70 TPD by the end of July.

Our Refined Glycerin unit is also performing steadily, operating at 80% to 90% of its installed capacity, ensuring consistent quality and output.

#### **Bio Diesel Business:**

Initially the Government introduced duty hikes in Palm Sterin and Edible oils in September 2024—which had pushed the basic rate to 20% and total effective duty to ~27.5%.

This led to increase in the buying rates of Biodiesel and OMC's companies put the buying of Bio diesel on hold for the next six months.

In the month of May 2025, the Basic duty slashed to 10%, bringing total effective duty down to ~16.5%. In spite of frequent challange in the Business environment, we are able to keep our head above the waters.

In the first quarter of FY 2025–26, our Biodiesel division had delivered strong performance. We have recorded a turnover of ₹ 100 Crore through the sale of 12,500 kilolitres of Biodiesel to the Oil Marketing Companies (OMCs), reflecting our commitment to efficiency, sustainability, and supply chain excellence.

These milestones reflect the strength of our integrated bioenergy platform and our team's dedication to scaling operations in line with national green energy goals. We are confident that the coming quarters will further reinforce our leadership in the renewable fuels sector.

#### **Industry News and Trends**

#### Biodiesel Industry: Key Trends in 2025

- India's blending target progress remains sluggish, with biodiesel blending at just ~0.6% in FY2025, far below the 5% goal by 2030. Achieving this target will require an estimated investment of ~₹2,500−₹2,500 Cr in supply chain development, infrastructure, and incentives
- OMCs released a major tender for Q1 FY2026 (~200 million liters biodiesel), signaling commitment ahead of mandatory penalties on unblended diesel starting April 2025.
- Biofuel adulteration controls: Rajasthan state is proposing legislation targeting B-100 biodiesel adulteration, with stricter penalties and licensing disqualifications.

### CNG / Bio-CNG Sector: Expansion & Challenges:

- India's CNG vehicle adoption is booming: sales expected to hit 1.1 million units by FY2025, doubling the fleet size from ~2.6 m in FY2016 to ~7.5 m—driven by expanding infrastructure (7,400+ stations) and diverse CNG vehicle models.
- Bio-CNG, produced via anaerobic digestion of waste, is gaining traction. About 127 operational CBG plants produce ~805TPD in India, supported by GOBARdhan and SATAT policies. A CBG blending mandate will become compulsory in FY2025–26, starting at 1%, and scaling to 5% by FY2028–29.
- While Bio-CNG offers strong energy security and environmental benefits, feedstock competition with biodiesel and consistent offtake remain challenges.
  S&P Global emphasizes the need for stronger policy push to scale this fuel source.
- At the state level, Chhattisgarh government has allocated concessional government land for Bio-CNG plants to drive urban waste utilization and renewable energy growth
